Based on those findings, the top 5 recommended priorities for immediate action in 2024 included:



**Improve IDENTIFICATION efforts** by TRAINING all organizations and professions who are in a position to recognize & respond to human trafficking in their local communities.



**Increase RESCUE/EXIT and RESTORATION program capacity** in order to provide both immediate and long-term support and services for all victims and survivors of either labor or sex trafficking, whether adults or children, foreign nationals or citizens.



**Improve DATA COLLECTION efforts** in order to more effectively develop and assess prevention and early intervention strategies.



**Increase efforts to address LABOR TRAFFICKING**, including educating at-risk populations with the knowledge they need to stay safe or self-report.



**Catalyze MULTI-SECTOR engagement** across the board in every community in order to expand and resource existing programs and services, meet needs, and fill identified gaps.

The TBI Human Trafficking Task Force and the Tennessee Counter Trafficking Alliance (TCTA) are actively engaged in and are providing leadership in each of these recommended priorities. The remainder of this Report catalogs the ways in which members of the Steering Committee for the Project are planning to engage these priority areas to strengthen Tennessee's response.

#### Alcoholic Beverage Commission

The ABC plans to strengthen anti-trafficking efforts in Tennessee by:

- Sharing human trafficking information and indicators with business licensees and individual servers, and

Strengthening local protocols and partnerships for when a potential case of trafficking is identified.

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing awareness for those in a position to identify human trafficking in local communities, 2) empowering those at-risk with the information they need to stay safe or self-report, and 3) strengthening efforts to address labor trafficking. #### Amerigroup

Amerigroup plans to strengthen anti-trafficking efforts in Tennessee by:

- Equipping frontline healthcare and child-serving professionals in their network to recognize and respond to human trafficking, and
- Developing a plan to detect early warning signs of potential human trafficking indicators among their members across the state.

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing training for healthcare providers and child-serving professionals in local communities, 2) improving data collection and analysis efforts, and 3) improving care for victims, survivors, and at-risk populations. #### **Attorney General's Office**

The AG's Office plans to strengthen anti-trafficking efforts in Tennessee by:

- Continuing to engage in a leadership role in the Human Trafficking Advisory Council, and
- Supporting the development of a plan to strengthen investigations and prosecutions of all forms of trafficking across all counties in TN

#### **Belmont University Data Collaborative**

Belmont plans to strengthen anti-trafficking efforts in Tennessee by:

Continuing to support Engage Together's Vulnerable Population Index score through data collection, analytics, and updates to assess and identify risk factors and vulnerabilities in each county, and

Supporting the work to help mobilize local community leaders to take collaborative action based on data-driven insights and strategies

These efforts will impact several identified gaps in Tennessee's response, including: 1) improving data collection and analysis efforts, 2) strengthening prevention and early intervention strategies for all victims of labor and/or sex trafficking, and 3) catalyzing multi-sector engagement to meet needs and fill gaps in their local communities. #### **Catholic Charities**

Catholic Charities plans to strengthen anti-trafficking efforts in Tennessee by:

Increasing awareness through multi-lingual and multi-medium campaigns aimed at educating recent migrants and refugees on human trafficking, and

Training staff and community partners working with at-risk individuals to recognize and respond to human trafficking

These efforts will impact several identified gaps in Tennessee's response, including: 1) empowering those at-risk with the information they need to stay safe or selfreport, 2) increasing training and support for those in a position to recognize and respond to human trafficking in local communities, and 3) strengthening efforts to address labor trafficking. #### **Children's Advocacy Centers of Tennessee**

CACTN plans to strengthen anti-trafficking efforts in Tennessee by:

- Coordinating with DCS's new Human Trafficking Unit to support victims of CSEC (commercial sexual exploitation of children), and
- Supporting the development of a plan to equip all healthcare professionals across the state to recognize and respond to human trafficking

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing training for healthcare providers and child-serving professionals in local communities, and 2) improving care for victims, survivors, and at-risk populations. #### **Department of Children's Services**

DCS plans to strengthen anti-trafficking efforts in Tennessee by:

Continuing to strengthen identification and interventions for child victims of human trafficking through its new Human Trafficking Response Team, and

Expanding agency and community partnerships to provide immediate and longerterm care and support for identified victims and those at high-risk

These efforts will impact several identified gaps in Tennessee's response, including: 1) strengthening identification and early intervention strategies for child victims of human trafficking, and 2) improving care for victims, survivors, and at-risk populations. #### **Department of Commerce & Insurance**

The TDCI plans to strengthen anti-trafficking efforts in Tennessee by:

Developing awareness and education campaigns for key professions, industries, and associations within DCI's network that need training on how to recognize and respond to human trafficking, and

Working with Engage Together to gather and analyze data that will illuminate opportunities to strengthen prevention strategies

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing training and support for those in a position to recognize and respond to human trafficking in local communities, 2) improving data collection and analysis efforts, and 3) catalyzing the business sector to join the fight alongside government and nonprofit leaders. #### **Department of Corrections**

The DOC plans to strengthen anti-trafficking efforts in Tennessee by:

Developing an assessment and referral process in women's prisons to identify potential victims of human trafficking, and

Expanding community partnerships to provide support and services to women who have experienced or are at-risk of human trafficking

These efforts will impact several identified gaps in Tennessee's response, including: 1) strengthening identification efforts for victims of human trafficking, 2) improving care for victims, survivors, and at-risk populations, and 3) expanding multi-sector engagement in local communities. #### **Department of Human Services**

The DHS plans to strengthen anti-trafficking efforts in Tennessee by:

- Building smoother bridges to access DHS-supported programs and services for youth aging out of foster care, and
- Providing training on how to recognize and respond to human trafficking to DHS grantees working with high-risk populations

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing training for those in a position to identify human trafficking in local communities, and 2) strengthening prevention and early intervention strategies for at-risk populations. #### **Department of Tourist Development**

The TDTD, in collaboration with Hospitality TN, plans to strengthen anti-trafficking efforts in Tennessee by:

- Promoting awareness of human trafficking for the travel, tourism, and hospitality sectors through various campaigns and mediums, and
- Training all security personnel at all welcome centers and rest areas across TN to recognize and respond to human trafficking

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing training for those in a position to identify human trafficking in local communities, and 2) catalyzing multi-sector engagement to end and prevent human trafficking. The TADEC plans to strengthen anti-trafficking efforts in Tennessee by:

Hosting events and activities across TN to increase education and collaboration among community partners and concerned citizens, and

Equipping their network to provide identification training to key community leaders, such as teachers, parents, program directors, and more

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing training for those in a position to recognize and respond to human trafficking in local communities, 2) expanding outreach to and support for at-risk populations, and 3) catalyzing multi-sector engagement. Leading training initiatives in collaboration with healthcare providers, DCS, DOC, and DOE to ensure front-line professionals can recognize and respond to human trafficking.

These efforts will impact several identified gaps in Tennessee's response, including: 1) increasing training for those in a position to recognize and respond to human trafficking in local communities, 2) expanding resources and care and collaboration for both labor and sex trafficking victims, survivors, and at-risk populations, and 3) increasing multi-sector engagement.
